



## Terms and Conditions

CONNECT by CBIGG is the ultimate “Member Benefit,” adding tremendous value at the Home Club and at all reciprocal CONNECT private country clubs and daily fee public golf courses. CONNECT benefits and eligibility requirements vary depending on the benefit level at which a CONNECT Member elects to participate. The benefits, requirements, and other terms and conditions for each of the CONNECT benefit levels are set forth below. CONNECT Members hereby agree to these terms and conditions of the CONNECT program.

Members of the private clubs which are owned by affiliates of C-Bon’s International Golf Group, Inc. (“CBIGG”) are eligible to participate in the selected CONNECT program at the desired benefit level by paying the required upgrade fees and dues as may be established and assessed from time to time, in the sole discretion of CBIGG. Such fees may be in the form of one-time fees, increased monthly dues or both. CBIGG reserves the right to waive, reduce or eliminate any applicable upgrade fees, in its sole discretion.

CONNECT Golf Members are required to be enrolled in a Golf category of membership at their Home Club and their account is required to be in Active status and in good standing.

CONNECT Non-Golf Members are required to be enrolled in a Non-Golf category of membership at their Home Club and their account is required to be in Active status and in good standing.

CONNECT may be used only by the primary Member or the Member’s Spouse, in any combination. Dependents on the Home Club membership account must be accompanied by the primary Member or Spouse of primary Member when visiting a CONNECT club.

### **CONNECT Dining and Social Benefit**

ALL CONNECT Members are entitled to receive a fifty percent (50%) discount on eligible á la carte dine-in food purchases made at the CONNECT Member’s Home Club and all CONNECT Private clubs. The fifty percent (50%) discounts do not apply to alcoholic beverages, canned / bottled sodas, or any other pre-packaged foods, i.e. candy bars, ice cream bars, peanuts, etc., or take out, catering, pantry orders or banquets. Special “CONNECT” pricing will be offered for various Member Social Events, Holiday Buffets, Holiday Special Events, and Specialty Dining Nights. Á la carte dining is currently available Tuesday through Sunday on a space available basis, as may be modified by CBIGG. CONNECT discounts do not apply at the CONNECT Affiliate Clubs.

## **CONNECT Golf Member Benefits**

CONNECT Golf Members are entitled to receive up to a maximum of two (2) rounds of golf, per club, per month, at all CONNECT and CONNECT Affiliate Private clubs, with complimentary green fees with the payment of the \$25 cart fee. Tee times are only available Tuesday through Sunday, and on a space available basis. Rounds at all CONNECT and CONNECT Affiliate Private clubs may not be used on Mondays or holidays, or at any other restricted time.

CBIGG reserves the right to impose additional restrictions on the availability of tee times at certain clubs during peak or high usage times or seasons, in its sole discretion.

Up to three (3) accompanied guests of CONNECT Golf Members will receive a fifty percent (50%) discount off the applicable guest fee rate at the participating CONNECT and CONNECT Affiliate Private club. The fifty percent (50%) guest fee discount for accompanied guests does not apply to the CONNECT Golf Member's Home Club.

CONNECT Golf Members are also entitled to receive unlimited complimentary greens fees at all CONNECT Affiliate public clubs, Monday through Friday, and after 2:00 PM local time on Saturdays and Sundays with the payment of the \$25 cart fee. Rounds may not be used on holidays, or at any other restricted time. CBIGG reserves the right to impose additional restrictions on the availability of tee times at certain clubs during peak or high usage times or seasons, in its sole discretion.

Up to three (3) accompanied guests of CONNECT Golf Members will receive a twenty percent (20%) discount off the applicable daily fee posted rate at the CONNECT Affiliate public club.

CONNECT Golf Members are also eligible to receive a twenty percent (20%) discount off the full retail price on all merchandise, if any, at all participating CONNECT and CONNECT Affiliate Private and public clubs.

CONNECT Golf Members are also entitled to receive complimentary use of the golf practice facilities at all CONNECT and CONNECT Affiliate Private clubs, restricted to the day of their confirmed tee time reservation.

CONNECT Golf Members are also eligible for tennis, fitness and athletic privileges at all CONNECT and CONNECT Affiliate Private clubs, subject to their benefit levels, the existence of applicable facilities and/or programs and certain restrictions established by CBIGG.

## **CONNECT Non-Golf Members Benefits**

CONNECT Non-Golf Members are eligible for dining, tennis, fitness and athletic privileges (excludes golf) at all CONNECT and CONNECT Affiliate clubs, subject to their benefit levels, the existence of applicable facilities and/or programs and certain restrictions established by CBIGG.

CONNECT Members receive access to the other Clubs but use their Home Club for league play, tournaments, associations, swim teams, weekend morning tee times, etc.

## General Terms

A listing of all participating CONNECT clubs and all CONNECT Affiliate clubs, as well as the terms, conditions and restrictions applicable to the CONNECT program are available at [www.CBIGGCONNECT.com](http://www.CBIGGCONNECT.com).

Connect Affiliate clubs only include the golf and facility usage benefits listed above and do not include the 50% off discounts on food.

All reservations for usage of CONNECT benefits must be made by contacting their Home Club. CONNECT Members may not contact other CONNECT clubs directly to make reservations. Members with the CONNECT benefit will make reservations for tee times by first contacting their Golf Professional at their Home Club, who will in turn contact the requested CONNECT and/or Affiliate CONNECT Club one day after the Host Club members. Dining reservations for special events at CONNECT clubs can be made by calling the Club directly at the phone numbers provided.

CONNECT Members will be required to use “member charge” as the form of payment for all discounted purchases at their Home Club or while visiting a Private Club. At Public courses cash or a credit card can be used as a form of payment.

CONNECT Member benefits may not be combined with other discounts, coupons or promotional programs.

CONNECT benefits and the CONNECT program may be modified, withdrawn and/or changed from time to time by CBIGG. CONNECT clubs and CONNECT Affiliate clubs are subject to change without notice, and may be added or removed from time to time. There is no guarantee that a specified number of clubs, or that specific clubs will always participate in the CONNECT program. CBIGG reserves the right to terminate or modify the CONNECT program at any time, create additional privileges, rights, benefits and programs to be made available only to certain benefit levels, from time to time, in its sole discretion. CBIGG reserves the right to terminate a club member’s participation in the CONNECT program if it determines that such Member has abused the CONNECT program or violated any of the terms and conditions applicable to the CONNECT program.

CBIGG reserves the right to restrict participation in CONNECT benefits to only those members of the Home Club who pay a required minimum “base dues” for their Home Club membership or to only those members who hold a certain minimum type or category of membership in their Home Club. For purposes of this Agreement, a “Home Club” is the private club at which a CONNECT Member’s base membership is located.

Each participating CONNECT Member agrees to abide by the rules and regulations of the CONNECT program, the CONNECT clubs and CONNECT Affiliate clubs he or she is visiting. Each CONNECT club and CONNECT Affiliate club reserves the right to refuse access to any person that it deems to have violated or be in violation of any of its rules and regulations or other codes of conduct. CONNECT benefits are nontransferable, and may not be offered, assigned or in any way transferred to any other person or entity.

CONNECT Members deciding to downgrade their CONNECT benefits would be subject to a **30 day written notice**. Should they wish to re-enroll to CONNECT in the future, they would be required to pay the current CONNECT fee at the time of their re-enrollment. The CONNECT fee is waived for the initial upgrade period only.

CBIGG makes no guarantees or representations regarding the availability of tee times. All tee times are provided on a first-come, first-serve, space available basis only.

CONNECT Members are responsible for payment of charges incurred through usage of their CONNECT benefits, including any applicable sales taxes or other fees or surcharges which may apply. CONNECT benefits, including complimentary and/or reduced greens fees, are not available as part of a Group Booking. CBIGG may determine in its discretion whether a request constitutes a "Group Booking," but at a minimum a "Group Booking" is defined as any single booking which requires two or more consecutive tee times at one CONNECT club or CONNECT Affiliate club on the same date.

In the event of any claim, dispute or cause of action of any kind arising under or in any way relating to these terms and conditions, or to the participation of any club member in any CONNECT benefit level, the amount of damages, if any, suffered by any participating member would be difficult to ascertain and the parties agree that such damages shall be limited to an amount equal to the amount of upgrade dues paid by that member as consideration for participating in their benefit level, if any, during the twelve months immediately preceding the events giving rise to the cause, claim or dispute. All parties further agree and understand that each CONNECT club or CONNECT Affiliate club is an independent entity, solely responsible for the administration of the CONNECT program, and no person or entity shall seek to hold any parent, subsidiary or affiliate of CBIGG responsible for any obligations or liabilities related to the CONNECT program in any way.
