III. Effect of Death

Membership in the Club does not confer upon a Member a vested or prescriptive right or easement to use the facilities. The Club’s Management has the right to restrict or reserve the Club and its facilities for maintenance or special events. Membership in the Club is a revocable license only and is subject to suspension and revocation for failure to abide by the Club’s Rules and Regulations as now in effect or as may be amended.
- C) Children and Guests. It is understood that we/I are fully responsible for any and all charges on this Membership which are signed by anyone listed on said Membership including all children designated on this application. Furthermore, due to the Club’s policy of not accepting cash for any purchases at the pool or in the restaurant areas of the Clubhouse, Members are fully responsible for any and all guests who accompany them at the Club. Responsibility includes both behavior and all food & beverage charges by their guests. However, any food or beverages for guests must be ordered and signed by the Member.
